Rules & Regulations Revised - 2018

1. SEASON

 Determined by the Board of Directors and will usually extend from the day school closes through Labor Day.

2. LIFEGUARDS

• The lifeguard is in charge of the Association facilities during the season.

They may forbid the use of, limit the use of, or may eject from the pool and grounds any person
who jeopardizes his own safety or the comfort of other members. Under such circumstances, a
person may regain full privileges only after a review and approval by the Board of Directors.

• The lifeguard on duty is responsible for watching the DEEP END OF THE POOL ONLY!

Parents are responsible for watching their own children in the shallow end.

The lifeguard is on duty from 12-5p.m., daily starting June 17th, 2017 and ending August 27th, 2017. Weekends only will be staffed starting May 27th, 2017 until opening day on June 17th, 2017.

• The lifeguard is NOT responsible for strewn garbage and/or sandbox/water toy pickup. This is a solely a MEMBER responsibility.

3. GENERAL CONSIDERATIONS

The Association will not be responsible for loss of, nor damage to, personal property.

The cost of any damage to Association property will be charged to the responsible active member.

A \$100 fee will be charged if a member loses their key.

Pets are NOT permitted upon the property of the Association.

Members are responsible for their children and guests using any of the Association's facilities.

Members may bring guests occasionally. All guests must be signed in. Members must accompany
guests; guests may not be at the quarry without a member.

Bathing suits are required at all times.

- Swim diapers, covered with waterproof pants are required at all times for non-potty-trained children.
 Swim diapers are available for purchase for a nominal fee. Please ask a lifeguard or find them in the shed.
- Absolutely no climbing on the rocks and no diving on the rocks. Signs are posted to this effect.

No portable radios, phonographs, or television sets are permitted in the swimming area/beach area.

Children 12 to 16 years old who have passed the Red Cross "Swimming Class" test may use the
facilities without parental supervision. This swimming privilege may be revoked if the lifeguard
decides that the child's behavior is unacceptable.

Children of members and guests 12 years and under must be accompanied by an adult.

A parent-member may appoint a non-member to accompany children, but it is understood that the
parent member retains the responsibility for the child or children even though absent. Non-member
adults must be registered with the lifeguard.

Adults are defined as individuals 16 years of age or older.

 Non-swimming children are not allowed in the DEEP END OF THE POOL unless accompanied by an ADULT SWIMMER! The lifeguard may administer a swimming test that children must pass to be allowed to swim in the deep end without parental accompaniment or floatation.

 Children are not permitted on the cement dock unless they have passed the lifeguard-administered swim test. This is to protect non-swimmers from any accident or injury in the deep end.

Removal of all personal trash is mandatory. Trash containers are provided for your convenience.

Children's soap bubbles are not permitted.

• Fires or barbeques must be in a grill and are NOT permitted on the beach directly. Please

use the new designated picnic area.

• THE FRONT GATE MUST BE LOCKED AFTER CLOSING TIME, ESPECIALLY IF YOU COME ONTO THE PROPERTY AFTER LIFEGUARD HOURS!!! Please lock the gate behind you to prevent trespassers!!

4. HEALTH AND SAFETY

Goggles, snorkels, flippers and beach toys will be permitted at the discretion of the lifeguards.

• Glass objects, other than eyeglasses, are not permitted in the beach area.

• CLIMBING ON THE ROCKS OR THE CLIFF IS STRICTLY PROHIBITED!!!!

No Fishing during swimming hours!

No unauthorized application of pesticides in or around the swimming area.

5. GUESTS

- Guest privileges are designed to permit members to enjoy their Association with special friends.
 Members are urged to be considerate in NOT placing a burden on the facilities at times when the weather is most favorable for use by member-families.
- A guest privilege shall consist of the admission of any non-member individual to the pool area for the duration of one day. PLEASE SEE LIFEGUARD WHEN BRINGING A GUEST!!!
 ALL GUESTS MUST BE REGISTERED BY AN ASSOCIATION MEMBER!!
- The guest privilege is an honor system at this time. However, please use discretion to prevent overcrowding and insure safety and enjoyment for the members.
- Any guest using the pool must be accompanied by and registered by a member. Please see the lifeguard. An adult must accompany guests under 12 years of age.
- The sponsoring member is responsible for the conduct of their guest.
- A one-season guest pass will be granted to an individual for \$25.00 upon application to and approval by the Board of Directors. The purpose of this season pass is to accommodate members' children who have a special friend they often play with whose family does not have a membership. The season pass is limited to ONE person only --- it is non-transferable, not even to other members of the individual's household. Grown children forming their own family must acquire their own membership.
- The Association Directors may grant additional privileges when deemed reasonable by circumstances.

6. PARTIES

 Permission to have a party (e.g. birthday, camping, etc.) of not more than 10 guests may be granted upon application to the Secretary of the Board of Directors in advance of the party.

7. UPON ARRIVAL

- ALL MEMBERS AND GUESTS MUST SIGN IN WITH THE LIFEGUARD.
- Members should check the board on the shed and at the entrance to the swim area for any notices, newsletters, or announcements.
